VICTIM: Leni Mandell

Occupation: film director



***Directing credits:** "Apocalypse of the Blind Hustling Rasta Skate Samurai From the Valley" (STATUS: production suspended)

***Autopsy summary:** Both lungs and the liver had a dark pigmentation. Toxicology report could not identify the toxin.

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the title of the project it is clear the victim's own mentality was somewhat disturbed.

SUSPECT #01: Corby LeGault
Occupation: actor, stunt person



***Criminal history:** MISDEMEANOR assault with a hockey puck made of goat cheese

***Interrogation transcript (excerpt):**

Detective del Fuego: According to records you pleaded no contest to misdemeanor assault with a hockey puck made of goat cheese. Why was the puck made of goat cheese?

Suspect#01: I have a rare autoimmune disorder that only allows for me to eat goat milk byproducts.

Detective del Fuego: Is it because your mother is a capricorn?

Suspect#01: Yes... and her moon is in retrograde.

Detective del Fuego: You seem the perfect fit to play the part of Oedipus. Why weren't you cast as Oedipus?

Suspect#01: The director said she needed me for my hockey playing skills.

Detective del Fuego: Ever been body checked?

Suspect #01: Occasionally.

Detective del Fuego: I need to check your body right now... bend
(inaudible)

Suspect #01: Is it because you... (inaudible) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #01: 1) did not properly engage as an infant with his mother's milk 2) did not properly engage in a body check, it is clear that his mentality is somewhat disturbed.

SUSPECT #02: Dan Anagnos
Occupation: film producer



***Criminal history:** CHARGES DROPPED due to lack of evidence for canine sex trafficking on a non-union production

***Interrogation transcript (excerpt):**

Detective del Fuego: What was the reason you had dogs on set on a previous production?

Suspect #02: It was a remake of Old Yeller.

Detective del Fuego: So... the dog was yellow?

Suspect #02: Yes.

Detective del Fuego: Was the dog a real bitch to work with?

Suspect #02: From all accounts the dog was a real gem.

Detective del Fuego: So... if given the chance... you would work with the dog again?

Suspect #02: I suppose.

Detective del Fuego: I'm gonna need detailed contact information for this dog.

Suspect #02: Is it because you... (inaudible) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #02 did not supply adequate information about the dog service when strongly coerced, it is clear that his mentality is somewhat disturbed.

SUSPECT #03: Niki Magarity
Occupation: film investor



***Criminal history:** EXPUNGED on charges of money laundering in excess of \$20.01

***Interrogation transcript (excerpt):**

Detective del Fuego: You invested money into the project?

Suspect #03: Yes.

Detective del Fuego: Are you rich or something?

Suspect #03: Or something?

Detective del Fuego: My 401k is... so so. Pension plan... not much better.

Suspect #03: That's nice.

Detective del Fuego: Should I be looking to diversify my personal portfolio?

Suspect #03: That's what they say.

Detective del Fuego: Pot stock... Go big?

Suspect #03: Is it because you... (inaudible) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #03 was unable to recommend a reasonably secure stock option, it is clear that her mentality is somewhat disturbed.

SUSPECT #04: Chad Tillner

Occupation: actor



***Criminal history:** PROBATION for impersonating Wolfman Jack at an all-night laundromat (even though Woldman Jack died five years earlier)... MISDEMEANOR trespassing for refusing to leave a laundromat

***Interrogation transcript (excerpt):**

Detective del Fuego: I bet it gets really itchy. Does it tend to get really itchy?

Suspect #04: Does what tend to get really itchy?

Detective del Fuego: Do you shampoo it every day?

Suspect #04: Do I shampoo what every day?

Detective del Fuego: Use a lot of products on it?

Suspect #04: Use a lot of products on what?

Detective del Fuego: Keep it nice and trim?

Suspect #04: Keep what nice and trim?

Detective del Fuego: Do a lot of laundry because of it?

Suspect #04: Oh... Um... uh... is it because you... (inaudible)
(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #04 repeatedly repeated questions set forth in his interrogation without supplying adequate answers, it is clear that his mentality is somewhat disturbed.

SUSPECT #05: Jody Bardin

Occupation: director of photography, camera operator



***Criminal history:** CHARGES DROPPED due to lack of evidence for conspiring to reboot the career of Alan Smithee

***Interrogation transcript (excerpt):**

Detective del Fuego: So... how is Alan Smithee doing these days?

Suspect #05: Possibly making a comeback.

Detective del Fuego: So... you worked with him a lot in the past?

Suspect #05: Occasionally.

Detective del Fuego: Have you ever worked with him on any films about detectives... a detective in the lead role?

Suspect #05: Can't say that I have.

Detective del Fuego: Does he accept unsolicited screenplays?

Suspect #05: As far as I know... no.

Detective del Fuego: Where does he usually hang out?

Suspect #05: He occasionally frequents the Lava Lounge.

Detective del Fuego: Alone... or with a bodyguard or something?

Suspect #05: Is it because you... (inaudible) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #05 was unable to supply adequate details about famed director Alan Smithee, it is clear that his mentality is somewhat disturbed.

SUSPECT #06: Debra Fan

Occupation: actor



***Criminal history:** CHARGES SUSPENDED for misdemeanor assault after “accidentally” spilling coffee on Salman Rushdie... PROBATION for apologizing to Salman Rushdie in Mandarin

***Interrogation transcript (excerpt):**

Detective del Fuego: So... you have experience with coffee on movie sets?

Suspect #06: 你說的話我聽不懂。(Nǐ shuō dehuà wǒ tīng bù dǒng.)

Detective del Fuego: 抱歉我法語不好。(Bàoqiàn wǒ fǎyǔ bù hǎo.)

Suspect #06: 給我留下深刻的印象。(Gěi wǒ liú xià shēnkè de yìxiàng.)

Detective del Fuego: 我看了很多中國電影。(Wǒ kànle hěnduō zhōngguó diànyǐng.)

Suspect #06: 你看很多犯罪劇嗎？(Nǐ kàn hěnduō fànzui jù ma?)

Detective del Fuego: 扇子? (Shànzi?)

Suspect #06: 我一般討厭警察。(Wǒ yībān tǎoyàn jǐngchá.)

Detective del Fuego: 我只是想驗證事實。(Wǒ zhǐshì xiǎng yànzhèng shìshí.)

Suspect #06: 是的...你是個混蛋。(Shì de... Nǐ shìgè húndàn.)

Detective del Fuego: I'll arrest you right now for not cooperating.

Suspect #06: 因為你... (Yīnwèi nǐ...) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #06 clearly isn't a fan of a certain member of the police force and his coffee drinking habit, it is clear that her mentality is somewhat disturbed.

SUSPECT #07: Greg Crooks
Occupation: hair/makeup artist



***Criminal history:** NONE

***Noteworthy feats:** Guinness World Record for staring at self in a mirror while on a movie set while no one was looking

***Interrogation transcript (excerpt):**

Detective del Fuego: Coffee... and a doughnut.

Suspect #07: Coffee and a doughnut?

Detective del Fuego: Black.

Suspect #07: Black?

Detective del Fuego: No sprinkles.

Suspect #07: No sprinkles?

Detective del Fuego: Half an hour?

Suspect #07: Half an hour?

Detective del Fuego: Make it two then.

Suspect #07: Make it two then?

Detective del Fuego: Ten-four... (inaudible)... I'm sorry, what were you saying?

Suspect #07: Oh... Is it because your... in your... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #07 clearly doesn't know what an earpiece is, it is clear that his mentality is somewhat disturbed.

SUSPECT #08: Bonnie Gillespie

Occupation: actor



***Criminal history:** PROBATION for sneaking out of the house after midnight to go see Hanson in concert... FELONY dereliction of duty for doing the Macarena before doing the MMMBop

***Interrogation transcript (excerpt):**

Detective del Fuego: ¿Cuándo fue la última vez que vio a Vitorino?

Suspect #08: I don't understand a word you're saying.

Detective del Fuego: ¿Vitorino fue a ver a Hanson?

Suspect #08: Hanson? Did you say Hanson? I saw them once.

Detective del Fuego: ¿Por qué no trajiste del Fuego contigo? del Fuego ama a Hanson.

Suspect #08: My mom and dad put me on probation for going to see them.

Detective del Fuego: No sales mucho ... ¿verdad?

Suspect #08: No, my dad is not a salesman.

Detective del Fuego: ¿Es porque tu ... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #08 clearly would not take a member of the police force to see Hanson if given the chance, it is clear that her mentality is somewhat disturbed.

SUSPECT #09: Kalimba Bennett

Occupation: actor



***Criminal history:** BREACH OF CONTRACT for not showing up to the set of "Hustlers" alongside Constance Wu & Jennifer Lopez

***Interrogation transcript (excerpt):**

Detective del Fuego: What's a decent size in the industry?

Suspect #09: I don't know? I guess it depends on the role?

Detective del Fuego: How does Matthew McConaughey get his part?

Suspect #09: I don't know... probably through his agent?

Detective del Fuego: Do you know Steven Soderbergh?

Suspect #09: I've never worked with him. My agent might know him.

Detective del Fuego: I'm gonna need your agent contact information.

Suspect #09: Oh... is it because you... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #09: 1) clearly doesn't know what a decent size in the industry is 2) clearly does know how Matthew McConaughey got his part 3) was unable to supply Steven Soderbergh's contact information, it is clear that her mentality is somewhat disturbed.

SUSPECT #10: Etana Jacobson

Occupation: assistant director, line producer, script supervisor



***Criminal history:** EXPUNGED charges for allegedly stalking the Dalai Lama on multiple occasions while impersonating Eddie Murphy

***Interrogation transcript (excerpt):**

Detective del Fuego: You were in charge of security on set?

Suspect #10: It was one of my many duties.

Detective del Fuego: How could someone not involved with production find out when and where a film is being shot?

Suspect #10: Ultimately... they would have to get in touch with the producer.

Detective del Fuego: And if the producer were not cooperative in that regard? Is there another way?

Suspect #10: They would have to somehow be involved with production.

Detective del Fuego: What's the easiest way to get involved with production?

Suspect #10: They could apply as an intern.

Detective del Fuego: How do they qualify as an intern?

Suspect #10: They have to be going to school for course credit.

Detective del Fuego: Oh... so they have to have some sort of proof?

Suspect #10: They have to show course registration... usually from the instructor.

Detective del Fuego: Oh... so the instructor signs some sort of piece of paper that verifies that they're enrolled in the course?

Suspect #10: That's pretty much it.

Detective del Fuego: Was that the standard protocol on this particular set?

Suspect #10: Oh... it's not because you... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #10 was unable to recommend a good photoshop artist and came up with the excuse that postproduction is not her forte, it is clear that her mentality is somewhat disturbed.

SUSPECT #11: Ron Mohl

Occupation: film production assistant



***Criminal history:** CHARGES DISMISSED for allegedly trying to extort his own 401K from the great grandfather of George Meany

***Interrogation transcript (excerpt):**

Detective del Fuego: You are a film production assistant... correct?

Suspect #11: Yes, that's correct.

Detective del Fuego: How does one qualify to be a production assistant? Do you have to go to film production assistant school? Take a course? Any of that?

Suspect #11: Nope

Detective del Fuego: Really? Then how did you come to be a production assistant in this particular instance?

Suspect #11: Online crew boards.

Detective del Fuego: Where online are these crew boards?

Suspect #11: Just google it.

Detective del Fuego: And it's easy to get hired?

Suspect #11: It is for independent productions... they'll hire anybody as a production assistant if they just do it for the experience.

Detective del Fuego: No pay?

Suspect #11: It's entry level... like an intern.

Detective del Fuego: But you still have access to the director?

Suspect #11: As a production assistant you pretty much have access to everyone.

Detective del Fuego: And because of this you can... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #11 does not have the power of a director, it is clear that his mentality is somewhat disturbed.

SUSPECT #12: Jonathan Gotsick
Occupation: sound technician



***Criminal history:** CLASS ACTION SUITE DISMISSED due to lack of evidence for conspiring to blackmail DARPA N3 Program operators

***Interrogation transcript (excerpt):**

Detective del Fuego: (inaudible)

Suspect #12: I took a course.

Detective del Fuego: (inaudible)

Suspect #12: She's my cousin's friend.

Detective del Fuego: (inaudible)

Suspect #12: There's nothing magical about the boom pole.

Detective del Fuego: (inaudible)

Suspect #12: I think there's a law about having to get paid to do that.

Detective del Fuego: (inaudible) (end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #12 somehow can't figure out how to read between the lines, it is clear that his mentality is somewhat disturbed.

SUSPECT #13: Danielle Bisutti

Occupation: actor



***Criminal history:** FELONY CONSPIRACY for blackmailing her expired library card into impersonating her unregistered SAG card.

***Interrogation transcript (excerpt):**

Detective del Fuego: What does SAG mean?

Suspect #13: Can you be more specific?

Detective del Fuego: According to your record you have a SAG card.

Suspect #13: Oh... It stands for Screen Actors Guild.

Detective del Fuego: Guild... as in union?

Suspect #13: Pretty much.

Detective del Fuego: You have to be unionized to act on set?

Suspect #13: Unless it's strictly a non-union production. You don't have to be SAG for that.

Detective del Fuego: Can a non... SAG... actor... still do SAG stuff in front of the camera?

Suspect #13: No... you would have to get your SAG card to do SAG stuff in front of the camera.

Detective del Fuego: (inaudible)

Suspect #13: Oh... is it because you... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #13: 1) clearly doesn't know what SAG means 2) was unable to produce a valid library card when strongly coerced 3) was clearly unable to volunteer to take a member of the police force to the library to drop off that member's son's overdue library books unless successfully bribed... which she was from the member's 401K 4) doesn't know what a member is, it is clear that her mentality is somewhat disturbed.

SUSPECT #14: Justin Bowler
Occupation: actor



***Criminal history:** 3 CHARGES DROPPED due to "lack of evidence" of attempted sexual assault of fellow cast members during filming of "Apocalypse of the Blind Hustling Rasta Skate Samurai From the Valley"... 1 CHARGE DROPPED of CONSPIRING to solicit the producer while on the set of "Apocalypse of the Blind Hustling Rasta Skate Samurai From the Valley" due to "lack of evidence"

***Interrogation transcript (excerpt):**

Detective del Fuego: So... you got off on a technicality?

Suspect #14: For what? Can you be more specific?

Detective del Fuego: Who's your lawyer?

Suspect #14: Am I being charged?

Detective del Fuego: (inaudible)

Suspect #14: My sister-in-law recommended him.

Detective del Fuego: (inaudible)

Suspect #14: Oh... is it because you... (inaudible)

(end of excerpt)

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #14 won't volunteer to be a wingman for a member of the police force, it is clear that his mentality is somewhat disturbed.

SUSPECT #15: Tom Conroy
Occupation: actor



***Criminal history:** UNKNOWN

***Interrogation transcript (excerpt):**

Detective del Fuego: What was your role on this particular production?

Suspect #15: I was Creon.

Detective del Fuego: Oh... so it was an educational film?

Suspect #15: I guess it could be.

Detective del Fuego: I guess the big question is... What are the side effects?

Suspect #15: Uh... I guess the pay isn't the greatest.

Detective del Fuego: Due to marketability? Insurance doesn't cover?

Suspect #15: Whichever.

Detective del Fuego: Is there a lot of discomfort involved?

Suspect #15: I suppose it occasionally goes with the territory?

Detective del Fuego: And how long does that last?

Suspect #15: Probably until I see my therapist.

Detective del Fuego: Is that because of surgery?

Suspect #15: No... my doctor just recommends a few pills.

Detective del Fuego: I understand that the behind-the-scenes footage is known as "2 Lungs & A Liver of Darkness." Why isn't it known as "Pancreas of Darkness?"

Suspect #15: (inaudible)

Detective del Fuego: Where do I sign up?

***BSS assessment:** The evidence obtained, namely the behind-the-scenes footage, clearly delineate the facts of the case. Additionally, based on the fact that Suspect #15: 1) doesn't have the power to sign up a member of the police force 2) doesn't know what "sign me up" means, it is clear that his mentality is somewhat disturbed.
